

Sometimes judges honor consensual marriages under seven years of age: contrary to the established canon, marriages of children of two and three years of age are recorded[3]. The first recorded law on the age of consent dates back to 1275 in England; as part of its provisions on rape, the Statute of Westminster 1275 made it a misdemeanour to "rape" an "underage woman", with or without her consent. The expression "within age" was then interpreted by the jurist Sir Edward Coke (England, 17th century) as the age of marriage, which at the time was more than a guide. For example, Mary Hathaway (born 1689) was only nine years old when she was married to William Williams [6] Sir Edward Coke "has made it clear that the marriage of girls under the age of 12 was normal, and the age to which a girl who was a wife was only four years old. In 17th-century Spain, an official legal document of the Central Council of the Madrid Inquisition (La Suprema) written in 1614 stated that "adults" were then considered to be "women over the age of twelve and men over the age of fourteen".[7] In the 16th century, a small number of Italian and German states established the Minimum age for sexual intercourse for girls, setting it at 12 years.
